regulation on a social photography competition
"Contrasts of social reality"
in the framework of the XI Student Scientific Practical Conference
"Social well-being of a person in the modern world"
(Perm, Perm State University, May 27, 2019)

1. General Contest Provisions

1.1. This Regulation regulates the status and order of the social photography competition "Contrasts of Social Reality" (hereinafter referred to as the Competition), the requirements for participants and works of the Competition, the procedure for submitting them to the Competition, the terms of the Competition and is valid until the completion of competitive events.

1.2. The founder and organizer of the Competition is "Perm State University". The Department of Social Work and Conflictology of the Faculty of Law is responsible for the organization.

1.3. The objectives of the Competition are:

- Drawing the attention of the young generation to the ideas of social justice, humanism, altruism, tolerance, patriotism;
- Awareness by young people of the need to reject, prevent and condemn spiritual devaluation, antisocial behavior, discrimination, extremism and violence;
- Expansion of knowledge of young people about the social problems of modern society, social work;
- Development of creative thinking and perception of social reality.

The competition is held to involve young people in the process of social development by providing an opportunity to express their attitude to current social problems.

1.4. Students of any educational institutions can take part in the competition.

1.5. Information about the Competition is published on the official website of Perm State University <http://www.psu.ru/> and in the group of the Social Work and Conflictology Department of the Faculty of Law in the social network VKontakte <https://vk.com/club1604794>.

2. Terms of participation in the competition

2.1. Students of any educational institutions who submitted an application and competitive work in accordance with the conditions of the Competition, in a timely manner, have the right to participate in the Competition.

2.2. To participate in the Competition, you must independently invent, develop and prepare an original author's photo on social topics that meets the objectives of the Competition. By submitting the work to the Competition, the participant guarantees his authorship and assumes responsibility for copyright compliance. The number of competitive works from one author (or group of authors) is not more than 5. A separate application is filled in for each competitive work.

2.3. An application for participation of the standard form from the author or group of authors should be attached to each competitive work (Annex No. 1). The application is a necessary document for inclusion in the list of contestants.

2.4. All competitive materials are provided in electronic form by e-mail to konf_socblago@mail.ru. Theme of the letter: "Social Photography Competition". 2 files must be attached to the letter: "Last name_application" (in MS Word format) and "Lastname_photo" (layout in jpg format up to 2.5 MB). In case the competitive work has been prepared by several co-authors, in the file name indicate only one of the last names (the main developer).

2.5. Participation in the competition is free of charge.

2.6. Submitted to the competition material must comply with the requirements of the legislation of the Russian Federation.

3. The procedure for organizing and conducting the competition

3.1. Competition Dates:

- Acceptance of competitive materials is from may 1 to may 22, 2019;
- The work of the expert committee to determine the winners of the competition and the internet voting for the audience award are from may 23 to 25, 2019;
- Summing up the competition and awarding the winners on may 27, 2019

3.2. The works of the nominees of the competition are presented to the public by placing on the university website, in the group of the Department of Social Work and Conflictology in the social network VKontakte and at the exhibition in the Perm State University (Perm, Bukirev st., 15).

3.3. Criteria for evaluation of competitive works:

- Compliance with ethics
- Compliance of the content of the work with the objectives and topics of the competition
- Visual expressiveness
- Artistic expression
- The originality of the author's intention
- Literacy and expressiveness of the accompanying text description of the presented photo work

3.3. Winners of the competition are determined by a specially created expert committee. The winners are awarded with diplomas, participants with certificates. If it is impossible to participate in the award ceremony in person, diplomas and certificates will be sent to participants in electronic form by e-mail.

3.4. Internet voting for entries begins after the end of the admission of competitive works and runs in parallel with the expert assessment. Any Internet user

can take part in the voting. Winners according to the results of Internet voting are awarded with special diplomas of laureates of the Competition.

3.5. The organizer of the competition reserves the right to use competitive works in conducting socially significant events, in methodological and informational publications, for posting on the Internet, for educational and other purposes without paying monetary remuneration to the author (group of authors), but with the obligatory indication of the author's name (co-authors).
